MA in Social Care Leadership and Management

ADMISSION CRITERIA

The programme entry criteria are a minimum 2.2 award in a BA Social Care (Level 8) (or allied professional level 8 qualification) with at least 3 years work experience in a social care service and with formal or parttime management/leadership experience. A personal statement of evidence to verify management and leadership experience will be required. Graduates with a BA Social Care (Level 7) with relevant social care work experience may be considered through the exceptional entry route by the Programme committee.



PROMOTING CAREER PATHWAYS

A level 9 MA in Social Care Leadership and Management (SCLM) equips graduates to compete for higher level roles in social care leadership and management in statutory and non-statutory organisations across the social care sectors (e.g. children's services, disability sector, youth work, addiction services, juvenile justice, homeless services, care of older people). During the programme students will actively engage with the work of relevant organisations including the Child and Family Agency (TUSLA); Inspection and Regulation Services and the Health Service Executive and non-statutory organisations.





PROGRAMME CONTENT

Students shall take core modules in:

- Leadership and Strategic Management in Social Care Work
- Contemporary Practice and Ethical Perspectives
- Governance in the Field of Social Care Practice
- Integrated Seminars 'Theory to Practice'
- Critical Social Policy
- Organisations: Culture, Change and Learning
- Legal Issues for Social Care Managers
- Research Methods
- Dissertation

In addition, students shall select one from the following optional modules (optional modules are subject to change and shall be run subject to a viable cohort).

- Social Care Leadership and Management European Study Trip
- Interventions in Child and Adolescent Mental Health
- Youth Offending and Youth Justice **Perspectives**
- Equality, Diversity and Inter-cultural Practice
- Risk, Protection and Resilience of Children and Vulnerable Adults
- Contemporary Issues in the Early Years
- Desistance: The Route out of Crime
- Deviance, Punishment and Social Control in Modern Ireland
- **Employment Law**



PROGRAMME STRUCTURE

The programme is a taught modularised programme of 90 ECTS, delivered in semesters of 13 weeks. It is offered in a part-time mode over two academic years with the dissertation submission in the Autumn following the second semester of 2nd year.

This programme is delivered in-person in our Grangegorman campus, Dublin

PROGRAMME FEES

The programme fees are €2,835.00 per academic year.

Fees are subject to increase on an annual basis.
